The bid bond of the losing bidders shall be returned immediately after the announcement of the winning bidder, while the bid bond of the winning bidder shall be considered as partial payment.

Unsigned proposal, proposal lower than the floor price, and those without the corresponding bid bond shall automatically be disqualified.
