



## INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The **DBP Data Center, Inc. (DCI)** through the Corporate Budget Approved by the Governing Board intends to apply the sum of **ONE MILLION AND FOUR HUNDRED FIVE THOUSAND PESOS** (Php 1,405,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for **Bid No. 2024-001**. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

DCI now invites Bids from eligible Bidders for the **SUPPLY AND DELIVERY OF SERVERS**. Delivery of the goods is required **within 15 days** from the issuance of Notice to Proceed (NTP). The description of an eligible Bidder is contained in Section II of the Bidding Documents, Instruction to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines. Interested Bidders may obtain further information from DCI at the address given below from Monday to Friday, 9:00 A.M. to 4:00 P.M.

A complete set of Bidding Documents may be purchased by interested Bidders from February 19 – 26, 2024 from the address below and upon payment of a nonrefundable fee. The method of payment will be Cash. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.

DCI will hold a **Pre-Bid Conference** at **2:00 P.M. of February 26, 2024** at DCI's Office, 9<sup>th</sup> Floor DBP Building, Sen. Gil Puyat Avenue corner Makati Avenue, Makati City, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids and eligibility requirements must be delivered to the address below on or before **12:00 noon of March 11, 2024**. All Bids must be accompanied by a Bid security in the form and in the amount indicated in any of the acceptable forms and in the amount stated in ITB Clause 18. Late Bids shall not be accepted.

**Bid opening** shall be at **2:00 P.M. of March 11, 2024**, at DCI's Office, 9<sup>th</sup> Floor DBP Building, Sen. Gil Puyat Avenue corner Makati Avenue, Makati City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the given address.

DCI reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without incurring any liability to the affected Bidder or Bidders.
